This cause came to be heard upon Petition filed by the Wise County Board of Supervisors requesting entry of an Order from this Court requiring, and establishing a date for a referendum on the issue of Sunday beer and wine sales in Wise County, Virginia, the Court having entered such Order setting the referendum for November 7, 2017 and the Clerk of Court having properly published notice of such election, and the Registrar having properly prepared such ballot, such election having taken place on November 7, 2017, and the electoral board by abstract dated November 13, 2017 certified such results to the Court and the State Board of Election.

It is the finding of this Court that all requirements have been satisfied and the results of the referendum allowing wine and beer sales on Sundays in Wise County, Virginia has been properly certified.

It is accordingly Adjudged, Ordered, and Decreed that sales of wine and beer between the hours of twelve o'clock post meridian (12:00 p.m.) of each Saturday and six o'clock ante meridian (6:00 a.m.) of each Monday shall be permitted in Wise County, Virginia.

The Clerk shall transmit a certified copy of this Final Order legalizing Sunday beer and wine sales to the governing body of Wise County, Virginia.
